Appointment of Ombudspersons under MGNREGA-2018

In exercise of the powers conferred under Sub-section (1) of Section 27 of Mahatma Gandhi National Rural Employment Guarantee Act, 2005 the Government of India has issued Instructions on Ombudspersons (as revised on 28.08.2017) to appoint Ombudspersons for each district for redressal of grievances and disposal of complaints and accordingly a selection committee under the Chairmanship of the Additional Chief Secretary to Government of Karnataka has been constituted.
