Appointment of Ombudsman under MGNREGA-2016

In exercise of the powers conferred under Sub-section (1) of Section 27 of Mahatma Gandhi National Rural Employment Guarantee Act, 2005 the Government of India has issued instructions on Ombudsman (as revised on 16.01.2014) to appoint Ombudsman for each district to resolve and redress the complaints and accordingly a selection committee under the Chairmanship of the Additional Chief Secretary to Government of Karnataka has constituted for appointment of Ombudsman.
