Appointment of Ombudsman under MGNREGA-2016

In exercise of the powers conferred under Sub-section (1) of Section 27 of Mahatma Gandhi National Rural Employment Guarantee Act, 2005 the Government of India has issued Instructions on Ombudsman (as revised on 16.01.2014) to appoint Ombudsman for each district for redressal of grievances and disposal of complaints and accordingly a Selection Committee under the Chairmanship of the Additional Chief Secretary to Government of Karnataka has been constituted to recommend appointment of Ombudsman. Applications were invited through news papers & Departmental website and the applications so received were placed before the Ombudsman Selection Committee Meeting held on 22.07.2016 for preparing a district wise panel of suitable persons for appointment as Ombudsman.
